Terms and Conditions "Quick Discount"

Welcome to "Quick Discount" These Terms and Conditions ("Terms") govern your access to and use of the Quick Discount mobile application and its related services (collectively, the "Service").

Please read these Terms carefully before using our Service.

By downloading, accessing, or using the "Quick Discount" App, you confirm that you have read, understood, and agree to be bound by these Terms and our Privacy Policy, which is incorporated herein by reference. If you do not agree to these Terms, you are not permitted to use the Service.

1. Definitions

- "App": Refers to the "Quick Discount" mobile application.
- "You": Refers to the individual downloading, accessing, or using the Service.
- "We": Refers to "A2Z Company", the owner and operator of the "Quick Discount" App.
- "Merchant": Refers to a third-party business that offers discounts through the App.
- "Electronic Personal Card": Refers to the unique, non-transferable digital identifier within the App, which may include a QR code and a numerical code, assigned to each User for the purpose of redeeming Discounts.
- "Discount": Refers to any promotional offer, deal, or reduction in price offered by a Merchant through the App.
- "Service" is defined to encompass everything, and the description of the Electronic Personal Card is more detailed and explicitly states it is "non-transferable."
- Loyalty Points ("Points"): Refers to the points earned by a User for qualifying transactions and activities within the App.
- **Reward Coupon:** Refers to a coupon with a value of 1,000 Egyptian Pounds, issued upon reaching 10,000 Loyalty Points.

2. The Ouick Discount Service

The "Quick Discount" App is a platform that connects Users with participating Merchants to discover and redeem Discounts. We act as an intermediary. The availability, terms, and conditions of any Discount are determined solely by the respective Merchant.

3. Account Registration and Security

- 3.1. To access the Service, you must register for an account. You agree to provide accurate, current, and complete information during the registration process.
- 3.2. You are solely responsible for safeguarding your account password and the security of your Electronic Personal Card. You are also solely responsible for all activities that occur under your account, whether or not you have authorized them.
- 3.3. You must notify us immediately at (<u>info@a2z-team.com</u>) or (0101.tel) of any suspected or actual unauthorized use of your account, password, or Electronic Personal Card.
- 3.4. We will not be liable for any loss or damage arising from your failure to comply with these security obligations.

4. Use of the Electronic Personal Card

- 4.1. **Issuance**: Upon successful registration, you will be issued a unique Electronic Personal Card within the App. This card is for your personal, non-commercial use only.
- 4.2. **Redeeming Discounts**: To redeem a Discount, you must present your Electronic Personal Card to the Merchant at the point of sale *before* payment.

The Merchant will validate the Discount by either:

- a. Scanning the QR code displayed on your Electronic Personal Card.
- b. Manually entering the unique numerical identifier from your Electronic Personal Card into their system.
- 4.3. **One-Time Use**: Unless otherwise specified by the Merchant in the Discount details, each Discount may only be used once.

5. Loyalty Program

- 5.1. **Participation**: All registered Users are automatically enrolled in the Loyalty Program. Participation is subject to these Terms
- 5.2. **Earning Points**: You will earn Loyalty Points for qualifying purchases made through the App at participating Merchants. The number of points awarded per transaction will be specified within the App. We reserve the right to change the rate at which points are earned.
- 5.3. **Reaching the Reward Threshold**: Upon accumulating 10,000 Loyalty Points, you will automatically receive a Reward Coupon with a value of 1,000 Egyptian Pounds.

5.4. Reward Coupon Terms:

- a. The Reward Coupon is valid for ninety (90) days from the date of issuance.
- b. The Reward Coupon is for one-time use and must be used in a single transaction.
- c. The Reward Coupon is non-transferable and cannot be exchanged for cash or combined with other promotional offers unless explicitly stated.
- 5.5. **Points Expiration**: Loyalty Points will expire if your account remains inactive (no transactions) for a continuous period of twelve (12) months.
- 5.6. **No Cash Value**: Loyalty Points have no cash value and are not your property. They may not be sold, transferred, or assigned to any other person.
- 5.7. **Program Modification and Termination**: We reserve the right to modify, suspend, or terminate the Loyalty Program, in whole or in part, at any time with reasonable notice. Any changes will be communicated through the App.

6. User Conduct

You agree not to use the Service to:

- Engage in any fraudulent activity, including but not limited to, creating multiple accounts, sharing your Electronic Personal Card, or attempting to redeem a Discount more than once unless permitted.
- Decompile, reverse engineer, or otherwise attempt to obtain the source code of the App.
- Use the Service for any illegal purpose or in violation of any local, national, or international law.

• Infringe upon the rights of any third party, including intellectual property rights.

7. Merchants and Third Parties

- 7.1. **Merchant Responsibility**: The Merchant is solely responsible for honoring the Discounts and Reward Coupons offered through our App and for the quality, safety, legality, and delivery of all goods and services provided.
- 7.2. **Disputes with Merchants**: Any dispute you have with a Merchant regarding a transaction, including but not limited to, the Merchant's refusal to honor a Discount or Reward Coupon, must be resolved directly with the Merchant. While "Quick Discount" may, at its discretion, provide assistance.
- 7.3. **Third-Party Links**: The App may contain links to third-party websites or services that are not owned or controlled by us. We have no control over and assume no responsibility for the content, privacy policies, or practices of any third-party websites or services.

8. Intellectual Property

All rights, title, and interest in and to the Service (excluding content provided by Merchants) are and will remain the exclusive property of "A2Z Company" and its licensors. The Service is protected by copyright, trademark, and other laws of EGYPT and foreign countries. You may not use our trademarks, logos, or trade dress in connection with any product or service without our prior written consent.

9. Termination

- 9.1. We may terminate or suspend your account and access to the Service immediately, without prior notice or liability, if you breach these Terms.
- 9.2. Upon termination, your right to use the Service will immediately cease. All provisions of the Terms which by their nature should survive termination shall survive, including, without limitation, ownership provisions, warranty disclaimers, indemnity, and limitations of liability. Upon termination, any accrued Loyalty Points and unused Reward Coupons will be forfeited.

10. Disclaimers and Limitation of Liability.

- 10.1. **Service**: The Service is provided on an "AS IS" and "AS AVAILABLE" basis without any warranties of any kind, express or implied.
- 10.2. **Limitation of Liability**: To the fullest extent permitted by applicable law, in no event shall "A2Z Company", its affiliates, directors, employees, or licensors be liable for any indirect, incidental, special, consequential, or punitive damages, or any loss of profits or revenues, arising out of your use of the Service.

11. Governing Law and Dispute Resolution

These Terms shall be governed and construed in accordance with the laws of Egypt, without regard to its conflict of law provisions. You agree to submit to the personal and exclusive jurisdiction of the courts located within Cairo to resolve any dispute or claim arising from these Terms.

12. Changes to Terms

We reserve the right, at our sole discretion, to modify or replace these Terms at any time. If a revision is material, we will make reasonable efforts to provide at least 30 days' notice prior to any new terms taking effect by sending an email to the address associated with your account or by providing an in-app notification. Your continued use of the Service after such changes become effective constitutes your agreement to the new terms.
